	wooded area of our site around a clearing.		

## **Operating Notes:**

- Supervision ratio is 1 instructor to maximum 16 participants, plus 1 additional adult to assist supervision (sometimes more than one extra adult depending upon the needs of a particular group).
- Instructor is trained to in-house syllabus. Refresher training as directed by coaching sessions and automatically if there has been a 3 month+ gap in leading the session. No special requirements for instructor, technical advice from Activities Manager and experienced Programme Leader.
- The course avoids areas of thorny or stinging vegetation.

**Risk – Benefit Statement:** There is a very low risk of minor injuries such as cuts, grazes and bruises, but high levels of participation in communication and teamwork development make the risk tolerable.

Blindfolded - walking into obstructions and/or collision with other participants	Visiting Children, Team Leaders, Teachers and Staff	Likely	Slight Harm	Activity supervised by a minimum of 2 responsible adults. Activity Leader positioned centrally for optimum overview of course, plus accompanying adult from visiting school or youth group at rear of activity group. Participants instructed to move at slow walking pace to avoid falling and the need to maintain left hand contact with rope at all times is emphasised. Opportunity to practise holding onto rope while sighted. Sighted leader communicates clearly upcoming hazards, process of passing on this communication practised at start of session and monitored throughout. One direction of travel strictly enforced to avoid collisions between young people who are appropriately spaced. Activity Leader is positioned to monitor and control participant flow. Certain individuals don't wear blindfolds if deemed appropriate by visiting staff. Option to complete the trail sighted and even with headtorches if dark (activity typically runs on first evening carousel though not exclusively). Nightline course is clearly marked and resources carefully controlled so participants only wear blindfolds in designated area. Groups are accompanied to and from nightline so Activity Leader can monitor compliance, assess potential characters within the group and guide group away from any hazardous terrain on the way to the activity.
