

Manual Handling	Visiting Children, Team Leaders, Teachers and Staff	Unlikely	Harmful	Leader briefing on good lifting technique, two children to each piece of equipment. Leader to advise on how to avoid finger injury during construction.	Leader to monitor and supervise.	Low
Splinters, cuts and bruises	Visiting Children, Team Leaders, Teachers and Staff	Likely	Slight Harm	Leader trained in First aid and First aid kit to accompany activity.	Leader to ensure all equipment is suitable for use and children are fully supervised.	Low
Entrapment between barrel and buggy	Visiting Children, Teachers	Unlikely	Harmful	Leader briefing, Leader to point out danger zones.	Leader to ensure loose clothing is tucked away	Low
Collision/ falling off	Visiting Children, Team Leaders, Teachers and Staff	Unlikely	Harmful	Speed to be limited by hand over hand propulsion.	Leader to make participants aware of the dangers of excessive speed	Low
Falling off in transit due to poor alignment between rope and buggy	t due to Team Leaders, Teachers and Staff en rope  Team Leaders, Teachers and Staff  Team Leaders, Teachers and Staff		ensure that buggy and rope are	Leader to remain vigilant and supervise fully.	Low	





















Collision with Vehicles	Visiting Children, Team Leaders, Teachers and Staff	Unlikely	Harmful	Compound gates to be closed, on a "Bin Day" (Wednesdays as of June 2022) Leaders are to move dumpster bins to the front of Soli Centre to be collected by the bin men prior to commencement of the activity. Activity station to be coned off.	Leaders to monitor any vehicular activity and stop the activity if required.	Low
Collapse	Visiting Children, Team Leaders, Teachers and Staff	Unlikely	Harmful	Leader to visually inspect buggy prior to use, Buggy not to be over loaded (No more than 2 adults or 3 children to ride buggy at one time)	Leader to ensure compliance.	Slight
Misuse of equipment	Visiting Children, Team Leaders, Teachers and Staff	Likely	Harmful	Leader to prohibit misuse of equipment. Small buckets to be used to reduce the risk of straining during "wet bog buggy activity".	Leader to ensure compliance.	Slight
Climatic conditions	Visiting Children, Team Leaders, Teachers and Staff	Likely	Slight Harm	Daily weather forecast obtained, and plans adjusted accordingly. Ensure all children are suitably clothed.	Communicate clear information to children prior to activity.	Low
